That advocacy takes shape through our leadership in broad coalitions — with CEO Ron Brown serving as President of the <u>California Alliance of Child and Family Services</u> and our select staff appointed to the <u>premiere initiative</u> to make California's Mandated Reporter laws more equitable and effective. We also encourage our local elected officials to prioritize child abuse prevention in their efforts. Thanks to our agency's partnership with <u>Council Member Eunisses</u> Hernandez, the LA City Hall building will be lit blue in honor of Child Abuse Prevention Month April 26-28.
