As we celebrate 120 years of service, we reflect on a legacy built on a steadfast commitment to creating a world where every child is safe to grow. This year, we proudly embraced our new identity as All For Kids, a name that reflects both our history and our vision for the future. This transformation represents more than just a new name—it embodies our ongoing dedication to making a lasting impact for children and families.

Our 120th Anniversary Gala, Decades of Hope, was a memorable event that united friends, partners, and supporters in celebration of our journey. It was a powerful reminder of how far we have come, and it reinforced our

Over the past year, we proudly served more than 50,000 children and their family members, meeting them at their point of need and ensuring they received the support they deserved with dignity and respect. With 85% of the funds raised going directly toward programs, we have been able to expand our reach and increase the impact of our services.

At the core of our work is Positive Prevention, which empowers families and communities to come together to build resilience and foster connections long before they face hardship. This approach is exemplified in our Family Resource Centers (FRCs), which act as community hubs across Los Angeles and Orange Counties. A significant milestone this year was the opening of our first owned

Family Resource Center in Palmdale, CA—an important investment in our future and in the Antelope Valley region. This beautiful, innovative center includes a children's library, a large outdoor garden, and a sports court, now serving local families by providing a welcoming space where they can access essential resources, build connections, and thrive. The site also offers rental space for those in the community who need to host meetings and special events.

As a learning organization, we also invest in our own development. This past year, our internal university, Elevate U, provided 8,785 total hours of training to 3,237 professionals, including our staff and place-based network groups, equipping them with the skills needed to better serve children, families, and communities. These efforts reflect our commitment to growth, both individually and collectively. Guided by our values of Accountability, Belonging, Inclusion, Diversity, and Equity (ABIDE), we continue to proudly foster a culture that embraces diverse perspectives and creates environments where every child can thrive.

Our financial growth and stability have enabled us to expand to a \$63 million agency, furthering our ability to reach more families. Advocacy is another cornerstone of our work. As President of the California Alliance of Child and Family Services this past year, I had the privilege of representing 160 nonprofit service providers statewide, advocating for policies that benefit children and families. Our legislative efforts, combined with the work of our dedicated staff, ensure that we remain a leading voice for change across California. I encourage you to read the highlights of our policy work featured in this report.

As we move forward as All For Kids, the progress we have made drives us to address the challenges ahead. Through meaningful collaborations, impactful community events, and policy advocacy, we remain a trusted resource and compassionate ally. Strengthening Families Through Protective Support

Through our work at All For Kids, we help families build the protective factors that safeguard children from adversity. By offering concrete support, encouraging resilience, and fostering social connections, we enable families to create stable and nurturing environments. Our services continue to ensure that every family has the support they need to overcome challenges and grow stronger together. These findings are based on 757 retrospective surveys conducted by diverse All For Kids prevention programs across Los Angeles and Orange Counties.

STORIES OF HOPE AND TRANSFORMATION

At the heart of All For Kids are the families and children whose lives are transformed through our programs. Each story is a testament to the power of hope, community, and positive change. These personal stories highlight how our efforts have impacted families and how they are growing in environments where they feel safe, supported, and empowered.

Meet Porchia: A Journey of Strength and Support Through Black Infant Health

Porchia's story is one of resilience, love, and the power of community. As a mother of four, including a teenager and three young children, her life is bustling with challenges and rewards. When she welcomed her youngest child just five months ago, Porchia found herself in need of additional support, especially with the demands of raising multiple children and the financial hurdles that followed. Thankfully, she connected with the Black Infant Health (BIH) program at All For Kids, and from that moment, her journey was transformed.



Introduced to BIH by a case manager, Porchia initially joined the prenatal group. "It helped me with everything—mental and physical health, raising my kids, and even connecting me with resources to help with utilities and baby essentials when I first came home from the hospital," she shares. Through lactation coaching, discussions on breastfeeding,

she has gained a community, a network of mothers and health professionals who help her set goals, track milestones, and manage the daily ups and downs. "It's a good support group for African American women. Even if you already have a support system, this is just more support. They're always there when you need them," she says.

BIH has helped her family in countless ways, from providing formula, diapers, and wipes to assisting with essential resources in times of financial strain. The practical support, combined with the meaningful incentives she receives by attending weekly group meetings, has empowered Porchia to be the best mother she can be. "I even received a car seat for my baby, which was such a huge help," she shares. "This is honestly the best program I've ever experienced. Even outside of group sessions, I know I can reach out to a Family Health Advocate for help."

and advice from a community of women experiencing the same challenges, Porchia found confidence, strength, and camaraderie. She says, "It's a nice feeling to talk to people going through the same thing. You're not alone."

Today, Porchia is part of BIH's post-natal group, and her journey with the program has only deepened her gratitude. Through BIH, Porchia has found more than just resources;

Father Engagement Program: Building Stronger Families Through Connection and Support

Our Father Engagement Program empowers dads to be the best they can be by providing a supportive space to share experiences, gain practical parenting insights, and overcome challenges together. Through expert-led sessions, hands-on strategies, and interactive activities, dads develop confidence, build stronger bonds with their kids, and connect with a community of like-minded fathers. At All For Kids, our program welcomes all dads, with flexible meeting times to fit busy schedules, fostering a sense of unity and growth that makes a lasting impact on families and communities.

Not only has it helped me interact with my kids better than ever, but I've also got to connect with other dads in the program. We connected as a group, shared our experiences, and helped support each other," one father in the program shared.

Havah's Story: Creating a Family Through Love and Resilience

Havah and her husband, high school sweethearts, had always dreamed of adopting. They initially believed the journey would be financially out of reach, but life's challenges—including the heartbreak of losing a child—led them to rediscover that dream. Through All For Kids, they found the guidance and support needed to make their dream a reality, ultimately welcoming three foster children into their home along with their two biological children. The family adopted the three children and share that each adoption brought unique experiences and challenges, as well as moments of joy and growth.

"We've been able to give our children a new beginning and a family where they're truly accepted."

Havah speaks of her three adopted children with deep pride, describing how each child has added a new chapter to their story. Her youngest, who came to them with developmental challenges due to early neglect, has blossomed in a stable and loving home. "The positive impact of love and a consistent family environment has been profound," she shares. "Watching them grow, seeing their personalities shine, and knowing they feel safe has been life-changing for all of us." Havah has also navigated relationships with each child's birth family, embracing openness and understanding as they have built a bridge of mutual respect. She shares the many ways she fostered this connection, such as using a journal to update birth parents and creating physical keepsakes like printed photos. "It's a



simple gesture, but it's meant a lot in keeping a respectful relationship," she explains.

Her story reflects not only the love and acceptance within her immediate family but also the support of an extended family that has embraced every child with open arms. "Our family has rallied around us and welcomed our children wholeheartedly, regardless of whether they're biological or adopted," she says. This sense of community has been a source of strength and joy, showing her children that they are cherished and supported.

Havah emphasizes the importance of community, sharing how fostering and adopting have positively influenced her children's lives and brought out the best in those around them. "The support from All For Kids, along with our extended family, has transformed our lives," she says. "We've been able to give our children a new beginning and a family where they're truly accepted."

In sharing her journey, Havah's story reflects the resilience and transformative power of love, community, and care. Through the joys and challenges, she and her husband have built a family defined not by blood but by commitment and open-hearted acceptance. Her journey is a testament to the beautiful and lasting impact of adoption, a reminder of the hope and healing that come from building a family through love.

Tatiana and Allen's Story: A Journey of Trust, Teamwork, and Transformation

For Tatiana and Allen, finding the right support has been life changing. Their children have faced unique challenges, such as managing anxiety and building social skills, so the couple sought a program that would provide therapeutic support while fostering a genuine, trusting relationship. They found that connection with All For Kids, a partnership that would soon prove transformative for the entire family.

All For Kids' approach goes beyond traditional therapy, creating a supportive environment that involves the whole family. The children began participating in sessions that encouraged them to openly discuss their struggles and work toward personal growth. Guided by a skilled and compassionate team, they became increasingly engaged,

The positive impact on the family dynamic was equally profound. All For Kids emphasized building cohesion and trust within the family unit, helping each member understand how they could contribute to a supportive and open home environment. This holistic approach enabled the children to express themselves more freely and recognize the strength of family connection. The staff did not just serve as therapists but as trusted allies, helping create a foundation of respect and openness that the family had longed for.

In addition to emotional support, All For Kids also filled practical gaps the parents had struggled with in the past. The program offered access to resources, guidance from parent partners, and personalized follow-up, ensuring the couple felt supported every step of the way. The team's genuine dedication went beyond standard care, creating a network of reliable, consistent support that extended outside of sessions and encouraged the family's growth.

Looking forward, Tatiana and Allen hope that the program continues to grow and provide the same opportunities to other families. They recognize that such programs are essential for helping children develop the self-regulation and resilience needed for adulthood. All For Kids has provided them with invaluable tools and a renewed sense of hope, knowing they have found a partnership that uplifts and empowers their family every step of the way.

Sara's Story: From Parent to Community Leader

Sara's journey with MCI Network (MCI) in Los Angeles is a story of growth, empowerment, and the transformative power of community. MCI, a collaborative initiative led by All For Kids, works to create lasting improvements in child well-being by building safe, supportive communities and encouraging shared responsibility for family success. Sara first connected with MCI through the Mommy and Me program, seeking help with parenting challenges. She did not realize this first step would inspire her to become a community advocate with a newfound sense of purpose.

Her early experiences with MCI sparked a curiosity about community involvement, eventually leading her to the MCI Leadership Academy. Initially unsure of herself as a leader, Sara soon discovered that even small contributions could create positive change in her neighborhood. "MCI taught me to recognize the power of my voice," she reflects, noting how this confidence reconnected her to her identity and motivated her to build a network focused on family well-being.

Sara's involvement with MCI has also enriched her family life, providing lasting friendships and practical tools to bridge the gap between child development knowledge and real-life parenting. She values the flexibility of MCI's virtual meetings, which help her balance parenting with her commitment to MCI, allowing her to connect with parents across communities and inspiring her daughter's interests in science, technology, engineering and mathematics (STEM).

Looking forward, Sara feels a growing sense of hope and responsibility. "I'm just scratching the surface," she says, eager to continue her journey. Her story highlights the impact of community engagement and the power of shared goals. Through MCI, Sara has found her voice and strength in community, collaboration, and shared purpose. POLICY ADVOCACY IN ACTION

This year, the All For Kids Advocacy Program made strides in protecting and uplifting the well-being of children and families across California. Through leadership, strategic community partnerships, and focused legislative action, we are paving the way for stronger, more resilient communities. Our work brings together local leaders, coalitions, and families to champion policies that prevent abuse and create lasting support systems. Below are a few highlights:

Community Engagement

* Events with Local Leaders

Engaged 16 elected officials at events such as the Magnolia Place Community Health Fair and Palmdale Family Resource Center Grand Opening.

Legislative Action

* Policy Agenda

Launched our first-ever Policy Agenda, outlining the bills and budget positions we support to promote child safety and well-being.

* Protecting Resources

Helped safeguard \$322 million for children’s preventive mental health and blocked billions in state budget cuts affecting family services, including preschool, Family Stabilization, and Medi-Cal for young children.

Advocacy Leadership

* Coalition Leadership

All For Kids President & CEO Ron Brown led the California Alliance of Child & Family Services (160 nonprofits); Director Adam Seiden spearheaded initiatives on the Inter-Agency Council on Child Abuse and Neglect.

* Expert Testimony

Provided insights on systemic improvements to governmental working groups and task forces on child welfare issues. Adam Seiden received the Winston Crouch Award for Innovation in Government.

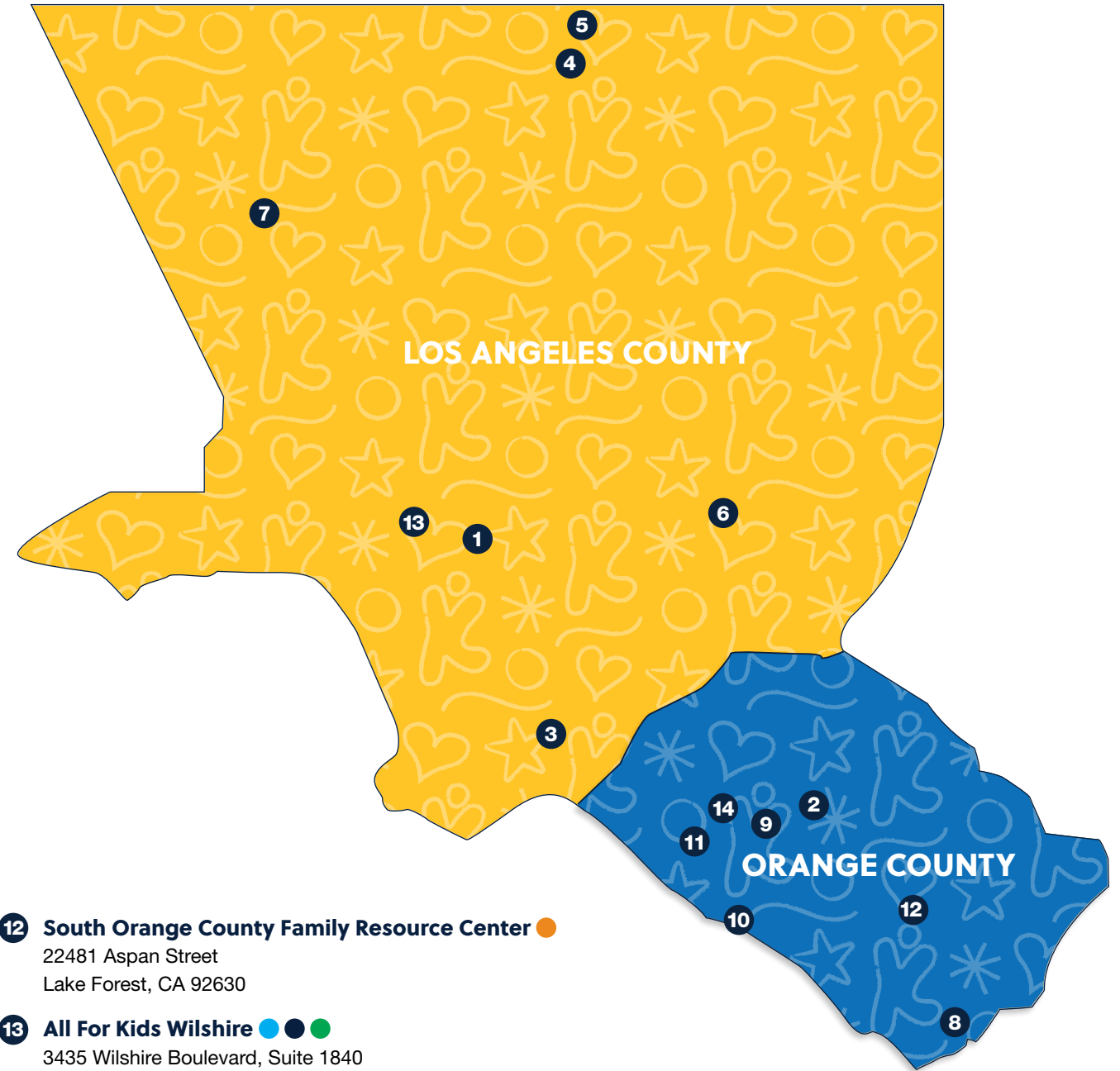
